**WHEREAS**, Downe Township carefully considers grant programs that assist the Township in achieving projects and programs that are priorities for the community; and


**NOW, THEREFORE, BE IT RESOLVED** that governing body of the Township of Downe formally approves a grant application for a municipal aid project.
