**RESOLUTION AUTHORIZING THE RENEWAL OF A MINING LICENSE
TO SILVI CONCRETE OF CHESTER COUNTY, LLC BY THE

WHEREAS, Silvi Concrete of Chester County, LLC has applied to the Downe Township Planning Board for renewal of a Conditional Use Permit and Preliminary and Final Site Plan Approval for issuance of a resource extraction permit; and

WHEREAS, the respecting premises is located along Dragston Road, Tom's Bridge Road and James Moore Road in the Township of Downe, County of Cumberland and State of New Jersey, being designated at Block 33, Lot4; Block 35, Lots 2, 3, 4, 5, 6, 7, 8, and 9, and Block 36, Lots 4, 7, 11, 12, 14, 15, 16, 18 and 23 on the Tax Maps of Downe Township; and

WHEREAS, Silvi Concrete of Chester County, LLC has met all the requirements of the Downe Township Mining Ordinance 90-7 as it applies to the Downe Township Combined Planning Board; and



NOW THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Downe, in the County of Cumberland and State of New Jersey that a five year Mining License is hereby issued to Silvi Concrete of Chester County, LLC subject to the conditions (1 - 7) set forth in the Downe Township Combined Planning Board

Resolution No. 2023-06 being met. The license is effective retroactive to January 1, 2023 and expires on December 31, 2027.
