## RESOLUTION AWARDING CONTRACT TO BOGEYS TRUCKING and PAVING FOR 2022 MUNICIPAL AID PAVING PROJECT FOR CORNELL AVENUE, NEWPORT AVENUE and PRINCETON AVENUE

WHEREAS, the Township of Downe advertised for bids for the paving of Cornell Avenue, Newport Avenue and Princeton Avenue within the Township of Downe; and

WHEREAS, bids were received on September 20, 2023; and

WHEREAS, the Township Committee of the Township of Downe is desirous of awarding a contract with respect to the paving of certain roads in the Township of Downe; and

WHEREAS, Bogeys Trucking and Paving Inc., 1779 Delsea Drive, Deptford, NJ 08096 submitted a base bid in the amount of \$130,475.20 and is deemed to be the lowest responsible bidder;

WHEREAS, the Township Engineer recommends that the contract be awarded to Bogeys Trucking and Paving Inc. for the base bid of \$130,475.20 which is within the amount of grant funding available from the NJDOT;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Downe that the contract for the paving of Cornell Avenue, Newport Avenue and Princeton Avenue in the amount of \$130,475.20 be awarded to Bogeys Trucking and Paving Inc. as the lowest responsible bidder; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Downe that the Mayor and Clerk be and are hereby authorized and directed to enter into a contract with Bogeys

Trucking and Paving Inc. as aforesaid in a form satisfactory to the Township Solicitor of the Township of Downe; and

- BE IT FURTHER RESOLVED by the Township Committee of the Township of Downe that bid bonds be returned to unsuccessful bidders; and
- **BE IT FURTHER RESOLVED** by the Township Committee of the Township of Downe that the award of the foregoing bid is contingent upon a certification of available funds being on file.
