RESOLUTION AUTHORIZING PROFESSIONAL SERVICE AGREEMENT WITH MOTT MacDONALD FOR BIDDING SERVICES FOR GANDYS BEACH BULKHEAD DAMAGE

whereas, the Township of Downe is in need of professional services with respect to additional design work and Bidding Phase Services for the Gandy Beach Bulkhead Damage Project, North Cove Road, Downe Township (FEMA Disaster 4574, Project 186326); and

WHEREAS, the Township of Downe received an updated proposal from Mott MacDonald to provide additional design work and bidding services which updates a prior proposal for the scope of work for the Gandy Beach Bulkhead Design FEMA project as described in their December 27, 2021 proposal; and

WHEREAS, such services are professional services by a recognized profession and are, therefore, exempt pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.); and

WHEREAS, the Township Committee of the Township of Downe is desirous of authorizing an agreement with Mott MacDonald to perform necessary engineering design work and bidding services in accordance with the proposal attached hereto and made a part hereof; and

whereas, the Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.) requires that the resolution authorizing the award of contracts for professional services without competitive bids,

and the contract itself, must be available for public inspection;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Downe in the County of Cumberland, State of New Jersey, that the Mayor and Clerk are hereby authorized to enter into a professional services agreement with Mott MacDonald, 3 Paragon Way, Freehold, NJ 07728 as annexed hereto for the additional work and bidding services for the Gandy Beach Bulkhead Damage Project.

BE IT FURTHER RESOLVED by the Township Committee of the Township of Downe that the foregoing is contingent upon a certification of available funds being on file.
