**RESOLUTION APPOINTING ANIMAL CONTROL OFFICER
FOR THE TOWNSHIP OF DOWNE**

WHEREAS, there exists a need to contract for Animal Control Services for the Township of Downe, County of Cumberland, and State of New Jersey, for the year 2024; and

WHEREAS, the Township of Downe desires to contract with Animal Control of South Jersey for the purposes of providing the services of Animal Control Officer; and

WHEREAS, the Township shall pay the Animal Control Officer, Animal Control of South Jersey \$3,000.00 payable at the rate of \$250.00 per month fee; and


WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that a Resolution authorizing the award of contracts for "Professional Services" and that the Contract be made available for public inspection:


NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

1. The Downe Township Committee hereby authorizes the Mayor and Clerk execute a form of Agreement with Animal Control of South Jersey for a period of one (1) year beginning January 2, 2024 through the date of Reorganization 2025 as Animal Control Officer.
2. That the Township of Downe agrees to the sum of \$3,000 payable at the rate of \$250.00 per month fee to the Animal Control Officer for services rendered to the Township of Downe.
3. The contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5 (1) (a) (i) of the Local Public Contracts Law because the services of the provider are specialized and extensive training and certification are required to satisfactorily provide such services.
4. A notice of this action shall be published one time in an official newspaper of the Township of Downe in accordance with N.J.S.A. 40A:11-5(1) (a) (i).
