**RESOLUTION APPOINTING ANIMAL SHELTER  
SERVICE PROVIDER FOR THE TOWNSHIP OF DOWNE**

**WHEREAS**, there exists a need to contract for an Animal Shelter Service Provider for the Township of Downe, County of Cumberland, and State of New Jersey, for the year 2024; and

**WHEREAS**, the Township of Downe desires to contract with the Cumberland County Society for the Prevention of Cruelty to Animals (CCSPCA) t/a South Jersey Regional Animal Shelter (SJRAS), for the purposes of providing Animal Shelter Services; and

**WHEREAS**, the Township shall pay the Animal Shelter Service Provider, South Jersey Regional Animal Shelter (SJRAS) in accordance with the 2024 Agreement to Provide Municipal Animal Shelter Services; and


**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et. seq.) requires that a Resolution authorizing the award of contracts for "Professional Services", and the Contract be made available for public inspection.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey, as follows:

1. The Downe Township Committee hereby authorizes the Mayor and Municipal Clerk to execute a form of Agreement with the SOUTH JERSEY REGIONAL ANIMAL SHELTER of 1244 North Delsea Drive, Vineland, New Jersey 08360, for a period beginning January 2, 2024 through December 31, 2024 as Animal Shelter Services Provider.
2. That the Township of Downe agrees to the pay fees per the *Agreement to Provide Municipal Animal Shelter Services* as attached.
3. A notice of this action shall be published one time in an official newspaper of the Township of Downe in accordance with N.J.S.A. 40A:11-5(1)(a)(i).
