**WHEREAS**, the Township of Downe has determined there is a need for Construction Inspection and Contract Administration services for the construction of the Gandy's Beach Bulkhead Repair Project, and

**WHEREAS**, the project will consist of improvement and extension of the Gandy's Beach bulkhead, demolition and construction, paving roads and restoring the site in accord with contract drawings and project description, and

**WHEREAS**, Engineering Design Associates, PA provided a proposal to provide the above mentioned services; and


**WHEREAS**, funds are available to make such expenditure and have been certified as such by the Township CFO. A certification of funds shall be attached to this resolution.
