RESOLUTION AUTHORIZING SHARED SERVICE AGREEMENT WITH COMMERCIAL TOWNSHIP TO PROVIDE SERVICES OF CERTIFIED RECYCLING COORDINATOR AS REVIEW AND CERTIFICATION AGENT REGARDING ANNUAL RECYCLING TOWNSHIP

WHEREAS, the Township of Downe desires to enter into a Shared Services Agreement with Commercial Township allowing the municipality to provide services as their Certified Recycling Coordinator; and

WHEREAS, pursuant to the terms of the Shared Service Agreement between the Township and Municipality listed below, will provide payment of specified monies in exchange for specified certified recycling coordinator services being performed by Commercial Township's certified staff; and

WHEREAS, said Shared Service Agreement are permitted under the Statutes pursuant to N.J.S.A. 40A:11-1 et seq., N.J.S.A. 18A-11 et seq., and Interlocal Service Act (N.J.S.A. 40:8A-1, et seq.) a local unit may enter into a contract with any other local unit to provide such services and shall require that the contract must be available for public inspection.

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Downe as follows:

1. The Township hereby authorizes the Township Mayor and Clerk to execute individual Shared Service Agreements for services of a Certified Recycling Coordinator in accordance with New Jersey Law and Regulation, with the following municipality.
