WHEREAS, LEW Environmental Services LLC is experienced and qualified in managing and providing administrative and testing services related to dust wipe sampling services, including but not limited to, educating the public as it regards lead paint sampling and testing requirements, direct billing of rental unit owners, maintaining a database of all rental units, status of compliance, results of testing/assessment and status of remediation of any; and

WHEREAS, the Township has received the attached Professional Service Agreement and wishes to contract for such services.
