WHEREAS, Downe Township carefully considers grant programs that assist the Township in achieving projects and programs that are priorities for the community; and


NOW, THEREFORE, BE IT RESOLVED that governing body of the Township of Downe formally approves a modification to the grant application for Old Beaver Dam Road.
