**RESOLUTION AUTHORIZING EXPANSION OF SHARED SERVICE  
AGREEMENT BETWEEN THE TOWNSHIP OF DOWNE AND COUNTY OF  
CUMBERLAND**

**WHEREAS**, the Township of Downe and the County of Cumberland are both providing services with respect to streets and road and winter storm repair and management; and


**WHEREAS**, the Township of Downe and the County of Cumberland have entered into an Inter-Local Services Agreement pursuant to N.J.S.A. 40:8A-1, et seq. to jointly provide, administer and bear the cost of such services; and

**WHEREAS**, the Township Committee of the Township of Downe finds that it needs to expand the agreement between the Township of Downe and County of Cumberland to assist in providing road opening and construction along New Jersey Avenue to facilitate water management via drainage infrastructure abutting 255 New Jersey Avenue and by way of Easement across the lands of Joanne Houser at Block 91, Lot 12 and expansion of such shared service agreement is in the best interest Downe Township;

**NOW THEREFORE BE IT RESOLVED**, that the Township Committee of the Township of Downe, County of Cumberland and State of New Jersey that the Mayor and Clerk be and are hereby authorized to extend its Agreement for Shared Services with the County of Cumberland pursuant to N.J.S.A. 40:8A-1 et seq in addition to the provision of planning and coordination concerning damages resulting from the winter storm of January 9, 2024 to add additional work to support drainage infrastructure along New Jersey Avenue abutting 255 New Jersey Avenue, Block 91, Lot 12 pursuant to an agreement, the form of which shall be satisfactory to the Township Committee and Solicitor of Downe Township and County of Cumberland.
