RESOLUTION ADOPTING THE 2025 TEMPORARY BUDGET

whereas, N.J.S. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the 2025 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this Resolution is within the first thirty (30) days of January 2025; and

whereas, the total appropriations in the 2024 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement funds, and public assistance is the sum of \$1,240,164.00; and

whereas, twenty-six and one quarter percent of the total appropriations in the 2024 budget exclusive of any appropriations made for interest and debt redemption charges and capital improvement fund in said 2024 budget is the sum of \$327,643.05.
