**RESOLUTION OF FINDINGS, CONCLUSION AND DECISION  
OF  
THE DOWNE TOWNSHIP COMBINED PLANNING BOARD**

**WHEREAS**, there exists a need for the Combined Planning Board of the Township of Downe (hereafter "the Board") to retain an engineer to render services to the Board including, but not limited to, the review of applications for development; and

**WHEREAS**, *N.J.S.A. 40A:11-1 et seq.* (the Local Public Contracts Law) requires an Award of contract for "Professional Services" without competitive bidding be authorized by Resolution and said Resolution must be available for public inspection;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMBINED PLANNING BOARD  
OF  
THE TOWNSHIP OF DOWNE, AS FOLLOWS:**

1. Thomas J. Tedesco, N.J.P.E. of Bridgeton, New Jersey, an engineer authorized to practice in the State of New Jersey, is hereby appointed Board Engineer for a term of one (1) year commencing on January 14, 2020 and ending immediately prior to the reorganization meeting on January 12, 2021, to perform professional services to and on behalf of the Board, pursuant to the Professional Services Contract attached hereto;

2. This appointment was awarded pursuant to *N.J.S.A. 40A:11-1 et seq.* based upon the proposal submitted by the Engineer and in consideration of the merits and abilities of the Engineer to provide the services as described herein.

3. Notice of this action shall be printed once in the office newspaper of the Township.
